Seminar Agreement

The host agrees to pay the sum of \$500.00 per day. A class deposit of \$100.00 is due in full to Chris Haughey to be returned with this signed contract, due on (date) _____. The host also agrees to pay all reasonable travelling expenses including meals, travel expenses (fuel, mileage and/or airfare) and lodging.

The host is responsible for supplying all students with a surface and any other supplies needed for the class. Chris Haughey will provide a list of supplies necessary and surface preparation instructions to be completed before the class date by the host. If preferred, the prepared painting surface is available at an additional cost of \$_____ per surface. Chris Haughey can also provide the paint if preferred at an additional palette fee of \$_____ per student.

Chris Haughey will provide each student with a pattern packet including: a color photo of the class project, line drawings for tracing and full painting instructions. The pattern packets are given to the students on the day of the seminar.

The seminar fee and expenses not paid directly by the host should be paid to Chris the day of the seminar. If cancellation is required, advance notification must be given to Chris Haughey by (date) _____. If notice is not given by the aforementioned date, the host is still responsible for paying all travel expenses incurred, surface preparation fees, and the deposit of \$100.00 will not be refunded.

In case of emergency cancellation by Chris Haughey for any reason, no fees will be assessed and Chris can work with you to reschedule the class for a future date. If rescheduling is not possible, the \$100.00 deposit will be refunded to the host, and no further expenses will be billed. The host does have permission to reproduce photos of the class project for advertising purposes.
